- 10. India Myanmar Thailand: Agreement between the Government of the Union of Myanmar, the Government of the Republic of India and the Government of the Kingdom of Thailand on the determination of the trijunction point between the three countries in the Andaman Sea 1976
- 11. Indonesia Malaysia: Agreement between the Government of Malaysia and the Government of Indonesia on the delimitation of the continental shelves between the two countries 1969
- 12. Indonesia Thailand: Agreement between the Government of the Kingdom of Thailand and the Government of the Republic of Indonesia relating to the delimitation of a continental shelf boundary between the two countries in the northern part of the Straits of Malacca and in the Andaman Sea 1971
