The 9th International Conference on the South China Sea hosted by the Diplomatic Academy of Vietnam (DAV), the Foundation for East Sea Studies (FESS) and the Vietnam Lawyers' Association (VLA) took place at Ho Chi Minh City on 27-28 November, 2017.

On 27-28 November 2017, in Ho Chi Minh City, the Diplomatic Academy of Vietnam (DAV), the Foundation for East Sea Studies (FESS) and the Vietnam Lawyers' Association (VLA) co-organized The 9th International Conference on the South China Sea themed "Cooperation for Regional Security and Development". This year's conference attracted nearly 200 participants, including over 90 international experts, 70 Vietnamese scholars and officials, 20 representatives from 17 foreign missions in Vietnam and 60 correspondents from 35 domestic and foreign news agencies. The conference is regarded as a prestigious annual forum on South China Sea issue, bringing together many of the world's leading experts in the field.


